**OUR 10-DAY/8-NIGHT ITALIAN & FRENCH RIVIERA ITINERARY:**

**DAY 1 – BOS~NICE:** Depart Boston's Logan Airport aboard our transatlantic flight to Nice (*via intermediate city*) with meal and beverage service, as well as stereo headsets, available in flight.

**DAY 2 – NICE~SAN REMO:** Upon arrival at the Nice Airport, we will be met by our Tour Host, who will help us transfer to our hotel in San Remo, Italy. The remainder of the afternoon is at leisure to freshen up before our orientation prior to dinner and overnight at the Hotel Des Anglais (*or similar*) in San Remo. **DAY 3– GENOA~CAMOGLI:** After breakfast, we are off to Genoa, the capital of the Province of Liguria and the birthplace of Christopher Columbus. We will visit the Palazzo Ducale, the Cathedral of San Lorenzo, the House of Christopher Columbus, the Palazzo Spinola, the Staglieno Cemetery, the Palazzo San Giorgio, and the Via XX September. We will enjoy lunch in a local restaurant, then it's on to Camogli, another beautiful coastal town. We will have time for individual exploration, shopping, or relaxing, then return to our hotel. Dinner and overnight. (B, L, D)

**DAY 4 – SAN REMO:** After breakfast, we will experience a full day of sightseeing in San Remo, one of the most beautiful and popular resorts on the Italian Riviera. Besides its wonderfully mild climate, San Remo is particularly noted for its extensive sports facilities, including a racetrack, numerous tennis facilities, sunny beaches, and a fine golf course. We will tour many of San Remo's most popular venues. Lunch is on our own. Return to our hotel for dinner and overnight. (B, D)

**DAY 5 – NICE~CANNES:** After breakfast, we will take a scenic drive along the Cote d'Azur to visit Nice and Cannes, two of the most glamorous gems on the French Riviera. Nice, one of the oldest developments in the world, has inspired many of the world's greatest composers, artists, and sculptors with its beauty. The city, France's second most popular tourist destination behind Paris, sports heavy English and Italian influences, with the former seen in the seaside Promenade des Anglais and the latter seen in several of the city's squares like the Place Garibaldi, Place Rossetti, and Place Massena. Cannes is home to the world's pre-eminent film festival and is the epitome of glamour. Return to our hotel in San Remo for dinner and overnight. (B, D)

**DAY 6 – MENTON~MONACO:** After breakfast, we'll depart for a visit to Menton, the famous lemon city. Located right on the coast with a backdrop of mountains, Menton offers a wonderful view. We will saunter through the Old Town with its narrow streets and café-lined squares. A walk up the steep street to the Basilica St. Michel, the Chapel of the Immaculate Conception and the Cathedral is worth the effort. Or you might prefer to relax at a café or in one of the several gardens in the city. In the afternoon we will visit the city of the Rich and Famous. The Principality of Monaco rests atop a rock peak above the sea, dominated by the Prince's Palace and the white-stoned Cathedral, the burial place of past sovereigns including Prince Rainier and Princess Grace. We will visit the wonderful Exotic Gardens and also have free time to soak up the atmosphere, grab lunch on our own, shop or perhaps visit the Oceanographic Museum or the world-famous Casino. Later, we return to our hotel for dinner and overnight. (B, D)

**DAY 7 – SAN REMO~ SANTA MARCHERITA-PORTOFINO-LIVORNO:** This morning, after breakfast and hotel check out, we are off to Livorno. Along the way we will stop at Santa Margherita Ligure, for a walking guided tour of one of the "newer" resorts on the Riviera (developed post-World War II). Then we will take the ferry to Portofino, a seaside resort of international renown, situated on a small gulf of unique beauty. We will enjoy lunch in a local restaurant. In early afternoon, we will return to Santa Margherita Ligure by ferry where we will meet our coach to continue to check in at Hotel Palace, Viareggio (*or similar*). Dinner and overnight. **DAY 8 – CINQUE TERRE:** After breakfast, we will depart to La Spezia, where we'll meet our expert local guide and board the train for a delightful ride to picturesque Cinque Terre. First, we will visit Manarola and enjoy lunch there in a local restaurant. We will board a boat to Riomaggiore, which some have called the most beautiful place on Earth. From there it's on, via train, to Monterosso, enjoying time there before boarding the boat back to La Spezia by ferry. We will return to our hotel for dinner and overnight. (B, L, D)

**DAY 9 – VIAREGGIO:** After breakfast, we have a day at leisure to relax, shop and explore on our own. Dinner and overnight at our hotel. (B, D)

**DAY 10 – FLORENCE~BOS:** After breakfast and hotel check-out, we will transfer to Florence Airport where we will board our flight to Boston (*via intermediate city*) with meal and beverage service, as well as stereo headsets, available in flight. (B)
