DAY 1 – BOSTON~DUBROVNIK: Fly Boston to Dubrovnik (*via intermediate city*), with meal and beverage service available when in flight.

DAY 2 – DUBROVNIK: Upon arrival at Dubrovnik airport, we will meet our English-speaking tour escort to transfer to our hotel, *Hotel Valamar (or similar)*, for check-in. The rest of the day is at leisure. Dinner and overnight at hotel. (D) *Hotel website:* <https://www.valamar.com/en/hotels-dubrovnik/valamar-lacroma-dubrovnik-hotel>

DAY 3 – DUBROVNIK: After breakfast this morning, we will meet our English-speaking guide for a walking tour of Dubrovnik city center. The oldest part of Dubrovnik - the Old Town - is located east of Lapad at the bottom of Srđ hill. It has well preserved cultural and historical heritage and is therefore inscribed on UNESCO's List of World Heritage Sites. Old Town's streets and squares are stone-paved while the architecture consists of elegant, terraced houses, monasteries, churches, palaces, galleries, and museums. The rest of the day at leisure for you to get lunch on your own, and to sightsee and explore the area. Back to hotel for dinner and overnight. (B, D)

DAY 4 – DUBROVNIK~MEDUGORJE~SPLIT: After breakfast this morning, we will check out and meet our English-speaking guide and board our motorcoach to Split via a stop in Medugorje. Medugorje is a small town in the Herzegovina region of Bosnia and Herzegovina and is one of the most popular pilgrimage sites in this part of the world. Many travel to Medjgorje to witness the apparitions of the Virgin Mary and to seek spiritual guidance and healing as this place holds a significant place in the hearts of many devout Catholics. Since 1981, six young people have claimed to have seen and received messages from the Virgin Mary. This has led to an influx of pilgrims from all over the world who come to Medjgorje seeking spiritual guidance and solace. The messages received in Medjgorje are said to be messages of peace, love, and hope, and many people have reported experiencing a profound sense of peace and renewal during their pilgrimage. An experienced local guide will provide insights into the spiritual significance of Medjgorje and its history on a guided tour. If there is enough time, it is possible to climb to the Apparition Hill and visit the Church of St. James. Enjoy lunch on own in your free time. Later on, we will continue to Split and check in at *Hotel Globo (or similar)*. Dinner and overnight at hotel. (B, D) *Hotel website:* <https://hotelglobo.com/>

DAY 5 – SPLIT: After breakfast this morning, we will meet our English-speaking guide to board our private bus to visit Split City Center. Our English-speaking guide will lead us on a walking tour of Split. The story of Split is 17 centuries old, dating to the time the Roman Emperor Diocletian decided to build his Palace right on the peninsula near the great Roman city Salona, where he wanted to spend the last years of his life. During these 1700 years the Palace slowly turned into a city, which to this day lures with its rich tradition, glorious history, and beauty of its natural and cultural heritage. The rest of the day is at our leisure. Lunch and dinner on our own today. Overnight at hotel. (B)

DAY 6 – SPLIT~HVAR~SPLIT: Today after breakfast, we will meet our English-speaking guide and transfer by private bus to the port of Split. Return ferry ticket Split ~ Stari Grad ~ Split. Our local English-speaking guide will take us on a Hvar walking tour with entrances to St. Stephen Church and Dominican Monastery. We will enjoy lunch at a local restaurant on Hvar Island. Depart Hvar Island via ferry back to Split where we will have dinner and overnight at our hotel. (B, L, D)

DAY 7 – SPLIT~ZADAR~OPATIJA: After breakfast this morning, we will check-out and board our private bus from Split to Opatija via Zadar. We will stop and meet our English-speaking guide for Zadar walking tour, a city that is both an atmospheric time machine and an open-air museum. Here on display, you will find some of the most beautiful monuments of architecture and cultural heritage of the eastern Adriatic coast. Lunch on own. After, we will continue on to Opatija where we will check-in to our hotel, *Hotel Paris & Casino (or similar)*. The rest of the day at leisure. Overnight. DAY 8 – OPATIJA: Today after breakfast, we will meet our English-speaking guide to board our private bus for a half-day program to visit the truffle farm in Istria. We will see a truffle hunt demonstration and have a truffle product tasting. The rest of the day is at leisure. We will go back to our hotel for overnight. (B)

DAY 9 – OPATIJA ~ VENICE: After breakfast this morning, we will check-out and say goodbye to Split and board our private bus transfer to Venice where we will meet our English-speaking guide to transfer to our hotel in Venice, *Hotel Carlton on the Grand Canal (or similar)* for check-in. The rest of the day at leisure and dinner on our own. Overnight at our hotel. (B) *Hotel website: <https://www.carltongrandcanal.com/>*

DAY 10 – VENICE: After breakfast, we will meet local guide will join us to show us around this unique city, “the Queen of the Adriatic.” We will visit San Marco's Basilica (outside), walk over small bridges to the Bridge of Sighs, and past winding waterways to the Rialto. After our tour, we will enjoy a Gondola ride. The remainder of the afternoon and dinner is at leisure. Overnight. (B)

DAY 11 – VENICE~BOSTON: After breakfast and hotel check-out, we'll transfer to the airport in Venice to board our return flight to Boston (via intermediate city), with meal and beverage service available while in flight. (B)
