## **OUR 9-DAY/7-NIGHT LAKE COMO & SWITZERLAND TOUR ITINERARY:**

**DAY 1 – BOSTON~INTERMEDIATE CITY~MILAN:** Depart Boston's Logan International Airport aboard our transatlantic flight to Milan (*via an intermediate city*) with meal and beverage service, as well as stereo headsets, available while in flight.

**DAY 2 – MILAN~LAKE COMO:** "Benvenuti in Italia" Arrival at Malpensa Airport in Milan where we will be met by our Tour Escort who will assist with our transfer. Board our private motorcoach for a scenic drive to Lake Como where we will check in at our 4-star hotel. The remainder of the day is at leisure to familiarize ourselves with our surroundings. Dinner and overnight at our hotel. (D)

**DAY 3 –LAKE COMO~BELLAGIO:** Breakfast at our hotel. Our morning begins with a guided morning tour of the beautiful town of Como, which has kept much of its ancient Roman street plan, beginning in the lovely Piazza Cavour which is surrounded by quaint cafés, colorful houses, and stately hotels. In the afternoon, we will travel by boat on a cruise from the town of Como, up the lake past gorgeous villas, to the picturesque town of Bellagio, where we can wander through the peaceful, narrow lanes and covered walkways lined with pastel-colored houses typical of the area. Return by boat and motorcoach to our hotel for dinner and overnight. (B, D) *Please note: mode of travel and touring (bus/ferry/walking) may vary dependent on hotel location.*

**DAY 4 – BERGAMO:** Breakfast at our hotel. Today's excursion will take us to Bergamo, which against the backdrop of the Bergamese Alps, is one of the most beautifully situated cities in Lombardy. Bergamo's Old Town is perched on a hill above, enclosed by ancient Venetian walls, while the modern city center sprawls across the plains below. Our walking tour begins in the Piazza Vecchia – the heart of the Old Town – and we will have the opportunity to view many of its most significant civic and religious monuments, including the Palazzo del Comune, Palazzo della Ragione, the magnificent Cathedral, St. Maria Maggiore, the Colleoni Chapel, with its frescoed dome by Tiepolo, and the beautiful Baptistery. Late-afternoon return to our hotel for dinner and overnight. (B, D)

**DAY 5 – LAKE MAGGIORE & THE BORROMEAN ISLANDS:** Breakfast at our hotel. Today, we will discover wonderful Lake Maggiore and the Borromean Islands. First on our agenda, we will drive to Stresa where we will board the boat for our cruise to Isola Bella for a tour of the sumptuous Borromeo Palace, and its magnificent and massive Italian-style gardens. We will next cruise to tiny Isola dei Pescatori, once a fisherman's island and Hemingway's favorite of the Borromean Islands. We will spend the afternoon exploring the island with its narrow alleyways and romantic churches. Return to Stresa by boat, then transfer by motorcoach to our hotel for dinner and overnight. (B, D)

**DAY 6 – ST. MORITZ, SWITZERLAND:** Breakfast at our hotel. This morning, we will head north, through Chiavenna in the beautiful Bregaglia Valley, to Castasegna where we will cross the Swiss border. Then, we will navigate the thirteen winding hairpin turns of the road through the Maloja Pass. After passing by crystal-blue Lake Sils, we will drive through Silvaplana (which is 6000 feet above sea level) to the world-renowned mountain resort of St. Moritz. Our short walking tour will include this chic town's most

historic and famous landmarks, including the Protestant Church (circa 1786), the idyllic Old Cemetery, and the Schiefer Turm (the Leaning Tower – all that remains of the old Romanesque Church of St. Maurice), leaving time for some shopping in this elegant town. Return to our hotel for dinner and overnight. (B, D)

**DAY 7 – MILAN:** Breakfast at our hotel. Departing our hotel this morning, we will head south to stylish Milan, a city with some of the world's most stunning art and architecture. Our walking tour will include viewing the flamboyant 14<sup>th</sup> century Gothic Duomo ("defended" by the marble statues of 2,224 saints and nearly 100 gargoyles), the legendary Teatro alla Scala opera house, and the beautiful Renaissance Church of Santa Maria delle Grazie. If available, we will visit its rectory to view Da Vinci's 15<sup>th</sup> century masterpiece "Last Supper" mural painting. Return to our hotel for dinner and overnight. (B, D)

**DAY 8 – LUGANO, SWITZERLAND:** Breakfast at our hotel. This morning, we will again cross the Swiss border for our full-day tour to Lugano, Switzerland. Lugano is nestled in a bay on the northern side of Lake Lugano, surrounded by the nearby Swiss Alps. The town center, with its Mediterranean-style squares and arcades, and numerous parks, invites us to laze around and enjoy the atmosphere. By the lakeside promenade are the famous Belvedere Gardens, which boasts not only magnificent camellias and magnolias, but also countless sub-tropical plants and modern works of art. Return to Lake Como for dinner and overnight at our hotel. (B, D)

**DAY 9 – MILAN~INTERMEDIATE CITY~BOSTON:** After breakfast and hotel check-out, we will transfer to Malpensa Airport in Milan to board our return flight to Boston (*via intermediate city*) with meal and beverage service, as well as stereo headsets, available while in flight. (B)

- ★ Tickets for our boat cruises on Lake Como and Lake Maggiore.
- ★ Comprehensive sightseeing package as described in the itinerary, including entrance fees, where applicable.
- ★ Services of a full-time Tour Escort who will accompany our group throughout the tour.
- ★ Expert English-speaking step-on guides where required.
- ★ All room and meal taxes, and gratuities to bellmen. A small per-night city tax may have to be paid directly to the hotel.
