OUR 9-DAY/7-NIGHT COSTA DEL SOL TOUR ITINERARY:

DAY 1 – BOSTON~MALAGA: Depart Boston's Logan International Airport aboard our TAP Air transatlantic flight to Malaga, Spain (*via Lisbon*). Meal and beverage service, as well as stereo headsets, available while in flight.

DAY 2 – MALAGA~TORREMOLINOS: Arrive in Malaga, Spain where we will be met by our motorcoach and Tour Escort for our transfer to Benalmádena on the Costa del Sol. We will check into the 4-star *Hotel Alay* (or similar), which is near the beach and close to a variety of dining and shopping options. The remainder of the day is at leisure. Dinner and an orientation at the hotel this evening. (D) Hotel website: <https://www.hotelalay.com/en/>

DAY 3 – RONDA: After breakfast, we are off on a full-day excursion to Ronda, which is situated on a rocky precipice in the Serrania de Ronda mountains. Here kings and nobles have sought out the peacefulness of the mountains and the incredible views of the river from the heights of the walkways. We will visit the Church of St. Maria la Mayor, the Ronda Bullring, the oldest in Spain and the home of modern bullfighting, and Bodegas la Sangre, a small winery, where we will be able to taste some wine. We will have lunch in Ronda at a local restaurant. Return to Benalmádena for some leisure time prior to dinner. (B, L, D)

DAY 4 – GRANADA: After breakfast, we will take a full-day trip to Granada, the center of splendor in Spain. Here, in the capital of Spain's last Moorish kingdom, we will visit the most outstanding example architecture of the period, the Nazari Alhambra, the fortress of the 13th century ruler, Al Ahmar. We will also visit the Water Gardens of the Generalife (*the Royal Summer Palace*) and the city center. Lunch in Granada will be at a local restaurant. Return to Benalmádena for dinner and overnight. (B, L, D)

DAY 5 – SEVILLE: After breakfast, we head off for our full-day tour to the Andalusian capital of Seville! We will visit the Cathedral (*the largest cathedral in Spain and resting place of the remains of Christopher Columbus*), the Reales Alcazar (*originally built by the Moors in 1181 and modified in the Mudejar-style after the Castillian conquest*), and the Barrio de Santa Cruz (*a labyrinth of alleys, shops and balconied houses with a distinctive charm*). Lunch in Seville at a local restaurant. Return to Benalmádena for dinner and overnight. (B, L, D)

DAY 6 – GIBRALTAR: After breakfast, today's full-day excursion takes us to the British isle of Gibraltar. We will enjoy a sightseeing tour of this famous rock fortress and hear about its turbulent history. Points of interest on Gibraltar include the Upper Galleries, the Moorish Castle, St. Michael's Caves, and, of course, the colony of Barbary apes. Lunch on Gibraltar will be at a local restaurant downtown. After returning to the mainland, time willing, we will have some time at leisure in nearby Marbella. Return to Benalmádena for dinner and overnight. (B, L, D)

DAY 7 – TOLEDO~MADRID: After breakfast and hotel check-out, we will depart for the capital of Spain – Madrid! We then head north through the beautiful Andalusian countryside to the central Spanish plain and Toledo. Here, we will visit the Cathedral (*famous for its Gothic architecture, Mudejar decorations and 750 stained-glass windows*), Santo Tome (*a 14th century Mudejar-style church*) and the Sinagoga de Santa Maria (*Spain's oldest synagogue*). Lunch in a local restaurant in Toledo. We then continue on to Madrid for hotel check-in and dinner at the 4-star *Princesa Plaza Madrid* (or similar). Princesa Plaza Hotel is centrally located in a lively cosmopolitan and entertainment area where you can enjoy popular coffee shops, tapas bars and restaurants, and find renowned shops. The hotel is ideally located in the heart of Madrid, walking distance to major city attractions. (B, L, D) Hotel website: <https://princesaplaza.com>

DAY 8 – MADRID: After breakfast, we will take a morning panoramic sightseeing tour of the Spanish capital of Madrid. The most prominent stop on our tour will be at the Prado Museum, which houses one of the most complete and valuable collections of paintings in the world. Its works include masterpieces by Velazquez, Raphael, Titian, Van Dyck, Rubens, Goya, Murillo, El Greco, and many, many others. Lunch is on our own and the remainder of the day is at leisure for some last-minute shopping, independent sightseeing or just to relax. Dinner and overnight in Madrid. (B, D)

DAY 9 – MADRID~BOSTON: Following breakfast, we will transfer to Madrid Airport for our return TAP Air flight (*via Lisbon*) to Boston. Meal and beverage service, as well as complimentary stereo headsets, available while in flight. (B)
