Today, Santiago remains the most important urban area outside of Havana, and is home to the birth of most forms of Cuba's long-lasting music. Visitors from around the world come to enjoy the music originating in Santiago. Of more political importance, Santiago is known for being the Cradle of the Revolution. Here, in 1953, Fidel Castro led an ill-prepared attack on Batistas Barracks at Moncada. And finally, a few years later after successfully toppling Batista and his dictatorship, Castro gave his victory speech in Parque Cespedes in Santiago. The region is well known for many other things. There are the ruins of French coffee plantations to the east of the city in the mountains that are recognized by UNESCO as a world cultural heritage site. The famed Cuban cigar has deep-rooted tradition in Santiago, as does the production of rum.
