## OUR 10-DAY/8-NIGHT HOLY LAND ITINERARY IS AS FOLLOWS:

**DAY 1 TUESDAY, APRIL 16: BOSTON -TEL AVIV:** We will depart Boston aboard our transatlantic flight to Tel Aviv. Food and beverage service en route, as well as stereo headsets for our listening and viewing enjoyment.

**DAY 2 WEDNESDAY, APRIL 17: TEL AVIV-JERUSALEM:** After our arrival at Ben Gurion Airport in Tel Aviv, we will proceed through customs to the sign for Groups Exit. Outside the terminal, we will be met by our host and transferred to our hotel in Jerusalem for dinner and overnight. (D)

**DAY 3 THURSDAY, APRIL 18: ISRAEL MUSEUM – YAD VASHEM - EIN KAREM – BETHLEHEM:** This morning, our first visit is at the Shrine of the Book in the Israel museum, to see the Dead Sea scrolls. We continue our excursion to visit the village of Ein Karem, the birthplace of St. John the Baptist and to the Church of Visitation where the Blessed Virgin Mary visited her cousin, Elizabeth, and proclaimed the "Magnificat". We will visit Yad Vashem which is the memorial that honors both the holocaust martyrs and the "Righteous Amongst the Nations" who have been recognized for their compassion and courage when risking their lives to save the lives of Jews. Continue to Bethlehem to visit the Church of the Nativity where Our Lord was born. We will also visit the nearby Saint Catherine's church built over the Grotto of Saint Jerome who translated the Bible. We will have a chance to visit the Shepherds Fields where the Angel appeared to the shepherds while keeping watch over their flocks during the night. Here we will celebrate Mass, hopefully in a natural cave that was used by the shepherds. Drive back to our hotel in Jerusalem for dinner and overnight. (B, D)

**DAY 4 FRIDAY, APRIL 19: MT OLIVE - PATER NOSTER – DOMINUS FLEVIT - GETHSEMANE MT. ZION – ST. PETER IN GALLICANTU:** After breakfast, ascend to the top of Mount of Olives and visit the church of Pater Noster where Jesus taught the Lord's Prayer. Enjoying a panoramic view of the old city of Jerusalem from the top of Mount of Olives. Walk dawn Palm Sunday to Dominus Flevit and continue to Garden of Gethsemane around the Rock of Agony. This afternoon we will visit the Church of the Dormition on Mt. Zion where Mary fell asleep. Nearby, we will visit the Upper Room, the place of the Last Supper. We will also visit the church of Saint Peter in Gallicantu. Here Peter denied Jesus three times. Back to our hotel for dinner and overnight. Dinner and overnight in Jerusalem (B, D)

**DAY 5 SATURDAY, APRIL 20: MASADA - QUMRAN – SWIM & FLOAT – BAPTISM SITE – JERICO:** Early breakfast in the hotel. Depart the hotel and visit the fortress of Masada, rising 1,200 feet above the desert plain. See the restoration efforts on the remains of buildings dating back to the fourth and fifth centuries AD. Continue along the Dead Sea shoreline to visit Qumran, finding place of the Dead Sea Scrolls. Enjoy a the Dead Sea experience; float on the Dead Sea (short time) before we go continue to drive along the Dead Sea shoreline to Qasr El Yahud, the baptism site on the Jordan River, the area of the first baptism on Jordan River and where John baptized Jesus. Drive to nearby Jericho and celebrate Mass at the Church of the Good Shepherd. View the Sycamore tree in Jericho to recall the story of Zacchaeus. We will also view the Mount of Temptation where the devil tempted Our Lord. Return to hotel for dinner and overnight in Jerusalem. (B, D)

**DAY 6 SUNDAY, APRIL 21: EASTER SUNDAY: STATIONS OF THE CROSS – HOLY SEPULCHER – OLD CITY; SAINT ANN – POOLS OF BETHESDA – WESTERN WALL:** This morning we will get up early and go to the old city in order to pray the Stations of the Cross ending at the Church of the Holy Sepulcher where we will celebrate Mass at the Empty Tomb of our Lord. We will visit the Basilica of the Holy Sepulcher. Go

back to our hotel for breakfast and some time to freshen up. Later this day we will go in the old city again to visit the church of Saint Ann and the Pools of Bethesda. We will also visit the Western Wall before we go back to the hotel and allow a free afternoon. Dinner and overnight in Jerusalem. (B, D)

**DAY 7 MONDAY, APRIL 22: BEIT SHE'AN - MT. TABOR – BOAT RIDE – TIBERIUS:** After breakfast, drive north along the Jordan Valley to visit Beit She'an, a strategically important location on the Jordan River with an Egyptian, Greek, and Roman history. Continue to Mt. Tabor, the Mount of Transfiguration to visit the place where Jesus was transfigured before his three beloved disciples Peter, James and John. Close the day with a boat ride on the Sea of Galilee before we go back to the hotel for dinner and overnight in Tiberius. (B, D)

**DAY 8 TUESDAY, APRIL 23: MAGDALA - MT BEATITUDES - CAESAREA PHILIPPI – CAPERNAUM – PRIMACY OF ST. PETER:** After breakfast, we will visit the church in Magdala on the shores of Lake Kinneret, famous for its boat-shaped altar. We drive to the Mount of Beatitudes to celebrate Mass where Jesus gave the Sermon on the Mount. We continue our drive north to the Golan Heights and come to Caesarea Philippi. Here Jesus asked his disciples "Who do people say that I am"? We drive back to the Sea of Galilee and visit Capernaum, the town where Jesus was a guest at the house of St. Peter during his public ministry. We will also have a visit to the Church of the Multiplication of Loaves and Fish and the nearby Church of the Primacy of St. Peter. Dinner and overnight in Tiberius. (B, D)

**DAY 9 WEDNESDAY, APRIL 24: CANA – NAZARETH - MT CARMEL - CAESAREA – TEL AVIV:** This morning we will make our trip to Cana of Galilee to visit the wedding church where Jesus performed his first miracle of changing water to wine. Here, married couples can renew their wedding vows. Continue to Nazareth to visit the church of the annunciation and pray Mass there. We continue our journey into the Carmel Mountain, where Elijah confronted the false prophets of Baal (1 Kings 18:17-46) and where the Carmelite Order began. We travel up the coast to visit Caesarea (Acts 8:40; 9:30). We will visit the Roman theater and Crusader ruins, where the Romans held Paul prisoner. Drive to Tel Aviv and check into your hotel for dinner and overnight. (B, D)

**DAY 10 THURSDAY, APRIL 25: TEL AVIV - BOSTON:** Following breakfast and hotel check-out, we will be transferred to the Ben Gurion Airport for our return flight to Boston with meal, snack and beverage service aloft. (B)
