3	Ocho Rios, Jamaica - Just like a mirage, the white buildings of Ocho Rios seems to appear unexpectedly from lush vegetation covering the coast. We suggest you try the many outdoor activities offered on its rivers, such as kayaking and tubing. Another must-see attraction are the waterfalls along the Dunn River: almost 200 meters of natural steps over which the water flows to then fall about 60 meters directly into the sea. To enjoy this spectacle to the fullest, these enchanting waterfalls can be climbed via stairs set on either side. The beach below with its extremely fine, pure white sand is equally beautiful.	9:00 a.m.	5:00 p.m.
4	Georgetown, Cayman Islands - The Cayman Islands are located in the British West Indies and George Town, the capital of the Cayman Islands situated on Grand Cayman. Cruise passengers will soon see why George Town is such a delightful stop-off destination. 5	Costa Maya - Puerto Costa Maya, where the Caribbean and Antilles MSC cruise ships dock, is out of sight north of Mahahual, but its influence is felt on cruise-ship days, when the village springs to life with souvenir stands and jet-ski rentals along the slick seafont promenade, an extremely miniature version of Playa del Carmen. The two towns in the area, Mahahual and the smaller Xcalak, were hit hard by Hurricane Dean in 2007. Mahahual was rebuilt, but Xcalak is still quite battered. On an MSC Caribbean and Antilles cruise you will typically stay around Mahahual, while divers and anglers head south to Xcalak. Cruise passengers that prefer dry land can tour the magnificent Mayan ruins in the walled city of Tulum. Finally for a dose of pure fun, join our ATV (all-terrain vehicle) jungle adventure. Families won't want to miss a trip to X-Caret, Cancun's largest natural adventure park.
