DAY 1 – BOSTON~INTERMEDIATE CITY~NAPLES: Depart Boston's Logan International Airport on our overnight flight to Naples (*via intermediate city*) with food and beverage service, as well as stereo headsets, available while in flight.

DAY 2 – NAPLES~SORRENTO: “*Benvenuti in Italia!*” Upon arrival at the airport in Naples, we will meet our Tour Escort, who will help us transfer. Board our private motorcoach for the drive to Sorrento for an included lunch on arrival and check-in at the 4-star *Hotel Michelangelo* (or similar). The remainder of the day is at leisure to get acquainted with the hotel and our surroundings. An orientation meeting, with “Welcome Drink,” will be held at the hotel prior to dinner. Overnight. DAY 3 – SORRENTO: After breakfast at our hotel, we will be hosted on a morning walk through the historical center of Sorrento, including a visit to the Museum of Correale which is situated in the 18th century palazzo at the east end of town, then we will be taken on a morning tour through the historic center of Sorrento, then we transfer to La Sorgente farm, a picturesque agricultural farm, belonging to the family *Marciano* which is nestled in the Sorrentine hills with a fabulous view of the city of Naples. We will “Piazza Party” and Mozzarella experience with demonstration of making mozzarella the old fashioned way. Back to the hotel and time for shopping. Dinner and overnight at our hotel. (B, L, D)

DAY 4 – ISLE OF CAPRI: Breakfast is at our hotel this morning. Today, we will visit the beautiful Isle of Capri! Our full-day excursion includes a round-trip ferry ride, light **lunch** on Capri, and a guided tour. The town of Capri is very chic with shops, hotels, and restaurants lying along winding streets. The main square, Piazza Umberto, has a pretty white church and several open-air cafés where we can sit and watch the world go by. We will also visit the Augustus Gardens and their magnificent view over the Faraglioni Rocks. In the late afternoon we return to the Italian mainland (*via JETFOIL*) and enjoy dinner and a relaxing overnight at our hotel. (B, L, D)

DAY 5- AMALFI DRIVE: After breakfast at the hotel, we will be taken on an excursion along one of the most scenic roads in the world – *The Amalfi Drive!* Our first stop will be above Positano, one of Italy’s most famous and elegant resorts. We will then continue our drive through the ancient marine republic of Amalfi. There will be some free time to visit the beautiful Cathedral of St. Andrew, explore the town or browse and shop. You will enjoy a light lunch in Amalfi and then return to our hotel for dinner and overnight. (B, L, D)

DAY 6 – POMPEII & NAPLES: Following breakfast, We will depart to in Pompeii for a guided tour of this city, destroyed by the eruption of Mount Vesuvius in 79 AD and, today, the some of the best preserved ruins of Roman times We will enjoy lunch and wine tasting in Pompeii. Afterwards, we will drive to Naples for a guided panoramic sightseeing city tour, including the most fascinating sites and highlights of the Parthenopean capital and we will also stop at Café Gambrinus for tasting the deliciousness “SFOGLIATELLA”. Back to the Hotel for dinner and overnight at our hotel this evening. (B, L, D)

DAY 7 – ROME: After an early breakfast, please check-out of our hotel, paying any incidentals you may have incurred. We are off to Rome! A stop for a light lunch (on own) will be made en route. Arriving in Rome, we will visit the glorious remains of Ancient Rome, birthplace of modern civilization and capital of the Roman Empire and learn how Julius Caesar and many almighty Emperors, conquered the world and thrived in the heart of the Roman Forum. We will see the Colosseum (outside) and you can discover the grandeur, the glory, and bloody past of this amphitheater. Then we will continue the visits to the Forum, the Palatine Hill, the Emperors' Palace, the Capitol, the Senate and much more. Late-afternoon check-in at *Hotel Palatino* or similar. Dinner and overnight at our hotel in Rome. (B, D)

DAY 8 – VATICAN CITY: We will have breakfast at our hotel before our visit to Vatican City, including a tour of St. Peter's Basilica, the Vatican Museum, and Sistine Chapel. Lunch today is on our own. The afternoon is at leisure where you have chance to visit on your own, the Modern Rome”. The historic centre of the city thru the Spanish Steps, Trevi Fountain, Piazza Montecitorio, the Pantheon and Piazza Navona! This evening, we will have Farewell dinner with live music at a local restaurant this evening. Overnight at our hotel. (B, D)

DAY 9 – ROME~BOSTON: Following breakfast, please check out of the hotel, paying any incidentals that you may have incurred. We will transfer to the Rome Airport
