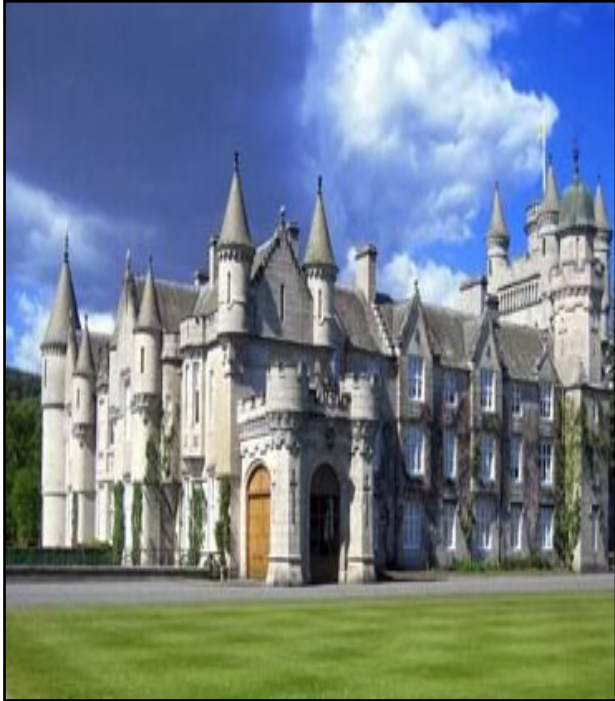

We will enjoy guided sightseeing, and breakfast and dinner daily while in Scotland, as well as the services of our expert Tour Escort.

## OUR 9-DAY/7-NIGHT STAY PUT SCOTLAND ITINERARY:

**DAY 1 – BOSTON~GLASGOW:** Depart Boston's Logan International Airport for our evening departure for Europe (via intermediate city) with full meal and beverage service available while in flight.

**DAY 2 – GLASGOW~DRYMEN:** Upon arrival in Scotland, we will meet our Tour Escort, who will help us transfer to the Winnock Hotel (or similar) in Drymen, near Loch Lomond, where we will spend the next seven nights. (D)

**DAY 3 – TROSSACHS~STIRLING:** After breakfast, today we'll enjoy a great day of sightseeing. We'll tour the nearby Trossachs, a beautiful area of lochs and mountains, and visit the Trossachs' town of Callandar, with its excellent craft and woolen shops. After lunch, we will continue on to Stirling to visit to the famous castle, a medieval old town, and the William Wallace ("Braveheart") Monument. (B, D)

**DAY 4 – EDINBURGH:** After breakfast, today we'll enjoy a full-day visit to Edinburgh. We will take a guided panoramic tour to view the historic Edinburgh Castle, the Royal Mile, Holyrood Palace, the famous Princes Street, and many of the lovely Georgian terraces of the "New Town." Lunch is at leisure in one of the bustling pubs. After lunch, we will have time for shopping and individual sightseeing. Depart from Edinburgh late afternoon and arrive back in Drymen in time to relax before dinner. (B, D)

**DAY 5 – GLENCOE~LOCH NESS:** After breakfast, today we travel via historic Glencoe and Fort William to the shores of Loch Ness for a little "nessie spotting." We'll also visit the Loch Ness Monster Exhibition at Drumnadrochit. (B, D)

**DAY 6 – PERTH:** After breakfast, we'll drive to the ancient capital, Perth, for a short visit before taking the road through Royal Deeside to Braemar, famous for its Highland Games. We'll see Balmoral Castle on the way to the quaint highland town of Ballater, frequented by the Royal Family. Time permitting, we will stop for a "quick nip" of whiskey at the Royal Lochnager Distillery, before returning to Drymen (B, D)

**DAY 7 – ARGYLL FOREST~OBAN~ISLE OF MULL:** After breakfast, today's journey takes us through the Argyll Forest, which is gloriously colorful. We will stop for a short visit of the famous Inveraray Jail on the way to Oban, the gateway to the Isles. From Oban, we will take a boat trip across to the pretty Hebridean Isle of Mull for a short visit before returning to Drymen. (B, D)

**DAY 8 – GLASGOW:** After breakfast, we will drive, via Glasgow, to visit the famous Burrell Collection. We'll stop in Ayrshire and Robert Burns country for a visit to the Burn's Heritage Centre and Robert Burns' Cottage before continuing on down the lovely Ayrshire Coast to Culzean Castle, with its strong links with the Kennedy family. We return to Drymen along the lovely coast road, past the Isle of Arran and Royal Troon Golf Course. We'll enjoy a "Farewell Dinner" at our hotel this evening. (B, D)

**DAY 9 – DRYMEN~GLASGOW~BOSTON:** After a last hearty Scottish breakfast, we will depart Glasgow Airport for our flight back to Boston (via intermediate city) with full meal and beverage service while in flight. (B)

- ❖ 7-nights' accommodations at the *Winnock Hotel* (or similar) in Drymen, based on twin occupancy. Single Supplement is an additional \$TBA per single. *Limited availability - may be unavailable or subject to surcharge.* Triples are available at the twin rate.
- ❖ Porterage of luggage at the hotel.
- ❖ Breakfast and dinner daily.
- ❖ Comprehensive sightseeing package, as described in the itinerary, including entrance fees, where applicable.
- ❖ Full services of a professional Tour Escort, who will accompany our group throughout the tour.
- ❖ Expert step-on tour guides, where required.
- ❖ All room and meal taxes, and gratuities to bellmen.
- ❖ Complimentary Durgan Travel Service flight bag.

**TRAVEL PROTECTION INSURANCE:** All persons traveling with **Durgan Travel Service** are automatically enrolled in **Travel Protection Insurance** through **Trip Mate (1-800-555-9095)**, *UNLESS* you "opt out" and check-off the "NO" box below on the Reservation Form. Please *ONLY* call **Trip Mate** if you have questions about your insurance or your eligibility. The plan covers trip cancellation or pre- or post-trip interruption, and tour operator/cruise line/airline bankruptcy up to the cost of the trip and trip delay up to \$750 (*max. \$150 per day*). Emergency evacuation is covered up to \$50,000. Accident or Sickness Medical Expense is covered up to \$25,000. Lost or stolen baggage/personal effects are covered up to \$2500. Baggage delay (24-hours or more) up to \$250 reimbursement, and life or dismemberment benefit \$25,000 max..

**TRIP DEVIATIONS:** Any request for tour deviation will be subject to availability at the time of booking. The *maximum* extension permitted is 10 - 14 days, depending on the airline. A deviation form, along with the surcharge fee of \$150, *should* be submitted at the time of initial payment, but will be accepted up to 120-days prior to departure. After processing, the request, any additional deviation expenses (car rental, train, hotel, etc.) must be paid, in full, to the Retail Department of Durgan Travel Service at the time of reservation.
