DAY 1: Transfer to Logan Airport and enjoy a flight to Kansas City. Upon arrival, we will be met by our tour director and motorcoach and transferred to Branson. Check in to the Branson Radisson (or similar) for dinner and overnight. (D) Hotel website: <http://www.radisson.com/branson-hotel-mo-65616/mobranso>

DAY 2: After breakfast at the hotel, we will enjoy the morning show of the Brett Family, a variety show held at Dick Clark's American Bandstand Theater. Following the show, we will visit Branson Landing, a lifestyle center with shopping, entertainment, and plenty of places to have lunch (on your own). Following a stop here, we will have a sightseeing tour of the Branson area, including a visit to the College of the Ozarks. Dinner this evening will be served on the "Branson Belle" during a river cruise! Return to the hotel for overnight. (B,D)

DAY 3: Following breakfast at the hotel, the morning will be free for time at leisure, where you may want to visit the nearby Titanic Museum or take in a morning show. We'll transfer to Old Downtown Branson for a chance to have lunch (on your own) before taking in the matinee "Million Dollar Quartet" performance at the Lawrence Welk Theater. Dinner this evening will be at Montana Mike's Steakhouse. Following dinner we will enjoy the "Liverpool Legends" show at the Caravelle Theater before returning to our hotel for overnight. (B,D)

DAY 4: After breakfast at the hotel, we are off to the King's Castle Theater for a performance by the Dublin Irish Tenors and the Celtic Ladies. Following the performance, we will transfer to the Grand Village Shops, a quaint village-style shopping area featuring local crafts, a gallery, a Christmas store, and famous Mel's Hard Luck Diner, where you may want to get lunch (on your own). Tonight, dinner is at Landry's Restaurant, followed by a visit to the Mickey Gilley Theater, where we'll be treated to a performance by Six, a musical act featuring the six oldest out of a family of ten brothers. Return to the hotel for dinner and overnight. (B,D)

DAY 5: This morning, we'll have breakfast and check out from our Branson hotel, and head to Memphis. Along the route, we'll have a stop for lunch (on your own). Upon arriving in Memphis we'll check in to our hotel, the Hampton Inn at Beale Street (or

similar). After a brief break to freshen up, we will go to the Peabody Hotel to watch the famous "March of the Peabody Ducks" followed by dinner at King's Palace on Beale Street, with the night free to enjoy this famous area. (B,D)

DAY 6: Following breakfast at the hotel, we will have a sightseeing tour of Memphis, including a visit to St. Jude's Pavilion, which holds memorabilia from the late entertainer Danny Thomas. Then it's on to Graceland, the famous estate of Elvis Presley. While here we will enjoy their "Platinum Tour" and have time for lunch on our own. After returning to the hotel, we will have dinner at Central BBQ or a similar Memphis eatery. Overnight at the hotel. (B,D)

DAY 7: After breakfast, we will check out of our hotel and have a tour of Sun Studios, where legendary artists like Elvis, B.B. King, Johnny Cash, Roy Orbison and U2 have recorded albums, prior to transferring to the Memphis Airport for our flight home. (B)

- Motorcoach transportation to and from Logan Airport. FREE with a minimum of 30 passengers. A slight additional charge possible with fewer than 30 passengers.
- Round-trip flights Boston-Kansas City and Memphis-Boston via regularly scheduled carrier. The identity of the carrier, which may include the carrier's code-share partner, will be assigned and disclosed at a later date.
- Special meet-and-greet service and assistance at Logan and Kansas City Airports, including portage of luggage and round trip transfers to and from our hotel.
- 7-nights hotel accommodations: 4 nights in Branson and 2 nights in Memphis based-on twin occupancy. For single supplement, add \$TBA per person. For triple reduction, deduct \$TBA per person.
- Breakfast and dinner included daily.
- Sightseeing as illustrated on the front side with the service of a local guide/host.
