OUR CALIFORNIA COAST ITINERARY:

DAY 1 – BOSTON~SAN FRANCISCO: Morning departure from Boston on a non-stop flight to San Francisco. Upon arrival late morning, we'll meet our guide for an extensive city sightseeing tour that will end late afternoon at the *Holiday Inn Fisherman Wharf* (or similar). Highlights of San Francisco include Fisherman's Wharf, Ghiaardelli Square, Lombard and Union Streets, the Golden Gate Bridge, the Presidio, Old Mission Dolores, Twin Peaks, and Golden Gate Park. (D)

DAY 2 – SAN FRANCISCO: This morning, we are off across the Golden Gate Bridge, visiting one of America's most spectacular natural wonders – Muir Woods. Here, we will see some of the largest redwood trees in the world and will have plenty of time to walk amongst these giants! After lunch (*on our own*), we'll take a tour of Alcatraz. Then we'll enjoy a stop at an overlook of San Francisco Bay for a spectacular scene of the "city by the bay." (B, D)

DAY 3 – SAN FRANCISCO: We'll enjoy a free day in San Francisco, to explore according to individual interests. Dinner is on our own tonight. (B)

DAY 4 – NAPA VALLEY: We'll meet our professional escort for a wonderful tour to Napa Valley! We'll visit two wineries and hear from vintners about the process of making wine! Then we'll enjoy a tasting at each. (Details to follow) Lunch will be on our own. Dinner and overnight. (B, D)

DAY 5 – MONTEREY BAY~CARMEL BY THE SEA~SAN SIMEON~SOLVANG~BUELLTON: We leave San Francisco for beautiful Monterey Bay. We'll have free time for lunch (*on our own*) and then we take the beautiful 17-mile scenic drive to Carmel-by-the-Sea! Next on our agenda is a stop at the famous Hearst Castle in San Simeon. We continue south, stopping for dinner along the way, to Solvang, a famed Dutch colony with a quaint village. Overnight at the *Quality Inn* (or similar) in Buellton. (B, D)

DAY 6 – SANTA BARBARA~LOS ANGELES: We depart Buellton and continue on to Santa Barbara, where we will have time at leisure to pursue one of many activities: take the Santa Barbara Trolley, enjoy the zoo, explore the waterfront, or stargaze, as Santa Barbara is home to many celebrities. We then leave for Los Angeles, where we'll check-in to the *Comfort Inn Universal Studios* (or similar) for the next two nights. (B, D)

DAY 7 – LOS ANGELES: Today we'll take a tour of world-famous Hollywood, including all the major sights. We'll see the Walk of Fame, Grauman's Chinese Theater, the Hollywood sign, Beverly Hills, and much more! We'll enjoy some free time to explore the city as well. Tonight we'll enjoy a special farewell dinner in a local restaurant. Overnight. (B, D)

DAY 8 – LOS ANGELES~BOSTON: After hotel check-out, we will transfer to the airport in Los Angeles to board our return flight. (B)

OUR CALIFORNIA COAST TOUR INCLUDES:

- ★ Round-trip motorcoach transportation to and from Boston's Logan International Airport, free with a minimum 35 passengers. Additional charge if fewer than 35.
- ★ Porterage of luggage at the hotels.

- ★ 7 nights' hotel accommodations at the hotel described in the itinerary, based on twin occupancy. The Single Supplement is an additional \$TBA per single. *Limited availability - may be unavailable or subject to surcharge.*
- ★ Comprehensive sightseeing package, as illustrated in the itinerary, including entrance fees, where applicable.
- ★ 7 breakfasts (B) and 6 dinners (D) are included.
- ★ All room and meal taxes, and gratuities to bellman.
