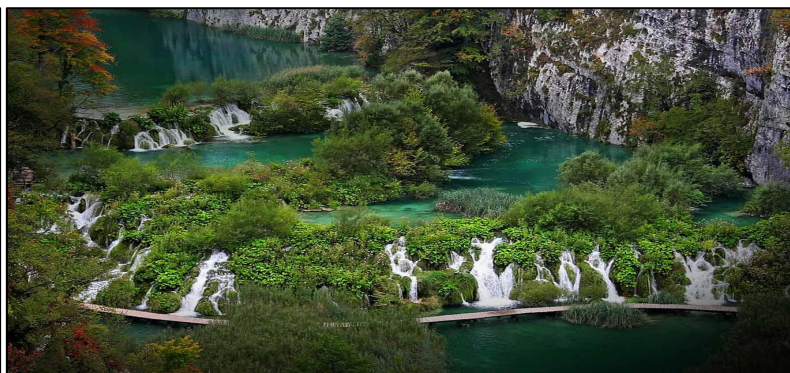

OUR 10-DAY/ 8-NIGHT CROATIA TOUR ITINERARY:

DAY 1 – BOSTON-INTERMEDIATE CITY-ZAGREB: Today marks the beginning of a new adventure! Depart Boston's Logan International Airport on a transatlantic flight (*with intermediate city*) to Zagreb, Croatia with full meal and beverage service, as well as stereo headsets, available while in flight.

DAY 2 – ZAGREB: Upon arrival we will meet our Tour Escort and board a deluxe motor coach. After lunch at a local restaurant en route to check into the *Hotel Four Points by Sheraton Zagreb* (or similar), we are treated to a city orientation. Dinner and overnight at our hotel. (L, D)

DAY 3 – ZAGREB: After breakfast at our hotel, we start the day with a half-day guided tour and funicular transport to Old Town Zagreb with a visit to the cathedral. Lunch is on our own with a free afternoon, allowing us flexibility to pursue personal interests. Dinner and overnight. (B, D)

DAY 4 – ZAGREB-BLED-LJUBLJANA: After breakfast and hotel check-out, we will enjoy a morning of leisure. After lunch (*on our own*), we enjoy a half-day guided boat ride to Bled Island where St. Mary's Church and Old Town Castle Bled are located. We continue to Ljubljana and check into the *Grand Hotel Union Business Ljubljana* (or similar) for dinner and overnight. (B, D)

DAY 5 – LJUBLJANA-SPLIT: After breakfast and hotel check-out, we head out on a half-day guided train ride to the Ljubljana Castle area. Lunch is on our own, after which we check into the *Hotel President, Split* (or similar). Dinner and overnight. (B, D)

DAY 6 – SPLIT: After breakfast, we will visit the Palace of Diocletian, built by the Roman emperor at the turn of the fourth century AD. Lunch is on our own, and the afternoon is at leisure. Dinner and overnight. (B, D)

DAY 7 – SPLIT~DUBROVNIK: After breakfast and hotel check-out, we depart by motorcoach for Dubrovnik, where lunch is on our own. The remainder of our day is at leisure. We will check into *Hotel Valamar Lacroma, Dubrovnik* (or similar) for dinner and overnight. (B, D)

DAY 8 – DUBROVNIK: After breakfast, we embark on a half-day guided tour of Rector's Palace, a UNESCO'S World Heritage Site. The Rector's Palace is a harmonious Gothic and Renaissance palace, with certain Baroque additions. The palace owes its present shape to many additions and reconstructions throughout its turbulent history. This afternoon is at leisure, after lunch on our own. Dinner and overnight. (B, D)

DAY 9 – DUBROVNIK: After breakfast and hotel check-out, we depart for a half-day guided tour of Plitvicka Lakes National Park. We will have time to stop for lunch on our own en route. Plitvice Lakes National Park is the oldest national park in Southeast Europe and the largest national park in Croatia. The national park, founded in 1949, is situated in the mountainous area of central Croatia, on the border of Bosnia and Herzegovina. The important north-south road connection, which passes through the national park area, connects the Croatian inland with the Mediterranean coastal region. In 1979, Plitvice Lakes National Park was added to the UNESCO World Heritage register. We check into *Hotel Jezero Plitvicka* (or similar) and enjoy dinner at our hotel. (B, D)

DAY 10 – ZAGREB~INTERMEDIATE STOP~BOSTON: After breakfast at the hotel, we will transfer to the Zagreb Pleso Airport for the return flight, with full meal and beverage service, as well as stereo headsets, available while in flight. (B)

OUR CROATIA TOUR INCLUDES THE FOLLOWING:

- ❖ Round-trip motorcoach transportation to and from Boston's Logan International Airport. FREE with a minimum of 35 paying passengers. Additional charge with fewer than 35.
- ❖ Special meet-and-greet service and assistance at Logan Airport by a Durgan Travel Service Representative.
- ❖ Round-trip regularly scheduled flights to and from Boston-intermediate city-Zagreb with full meal and beverage service, as well as stereo headsets, available while in-flight.
- ❖ 8-nights' first-class accommodations at the hotels described in the itinerary all based on twin occupancy. The single supplement is an additional \$TBA per single. *Limited availability - may be unavailable or subject to surcharge.* Triples available at the twin rate.
- ❖ All transfers and touring via a private, deluxe, temperature-controlled motorcoach.
- ❖ Porterage of luggage at the hotels.
- ❖ 8 breakfasts, 1 lunch, and 8 dinners (D).
- ❖ All room and meal taxes, and gratuities to bellmen.

- ❖ Professional Tour Escort, who will accompany our group, as indicated on the itinerary, throughout the trip.

A DEPOSIT OF \$TBA IS DUE UPON RECEIPT OF FLYER.THE BALANCE IS DUE 75 DAYS PRIOR TO DEPARTURE.

Emergency evacuation is covered up to \$50,000. Accident or Sickness Medical Expense is covered up to \$25,000. Lost or stolen baggage/personal effects are covered up to \$2500. Baggage delay (24-hours or more) up to \$250 reimbursement, and death or dismemberment benefit \$25,000 max.

After processing the request, any additional deviation expenses (car rental, train, hotel, etc.) must be paid, in full, to the Retail Department of Durgan Travel Service at the time of reservation.
