## OUR ITINERARY FOR OUR WONDERFUL TOUR OF THE FRENCH RIVIERA IS AS FOLLOWS:

**DAY 1: BOSTON~ZURICH~NICE:** Depart Boston's Logan International Airport in the late afternoon on our transatlantic Swiss flight for Nice Airport in France (*via Zurich*) with full meal and beverage service, as well as stereo headsets, available while in-flight.

**DAY 2: NICE~CANNES:** Arrive at the Nice Airport where we will be met by our Tour Escort who will assist with our transfer. Board our private motorcoach for a scenic ride along the Cote d'Azur to Cannes. Then, we are off to the 4-star *Hotel Embassy* (or similar) in Cannes for check-in. The remainder of the day is free time to rest and relax or visit the cities and beaches of French Riviera. (D) *Hotel website: www.hotel-embassy-cannes.com*

**DAY 3: NICE:** Breakfast at our hotel. We will enjoy a full-day visit to one of the French Riviera's most famous spots - Nice! We will go on a guided walking tour of the Old Town and take a leisurely drive along the famous Baie des Anglais, followed by a stroll along the promenade to take-in some of the historic sites, such as the *Hotel Negresco*. Lunch will be in Nice and then the afternoon is free to shop, relax or explore this charming town. We will return to our hotel late in the afternoon. Dinner is at the hotel this evening. Overnight. (CB, L, D)

**DAY 4: MONTE CARLO~CANNES:** Breakfast at our hotel. This morning, we will head-off for a full-day excursion to Monte Carlo, including a panoramic tour of the city. Box lunches, prepared by the hotel, will be served for the noon meal. The afternoon is at our leisure to explore the city, stroll the waterfront or, perhaps, visit the Royal Palace or the Monte Carlo Casino. Return to the hotel to freshen-up and have dinner. And then we are off for a night at the Casino in Cannes, for those that feel lucky! Overnight. (CB, L, D)

**DAY 5: GRASSE:** Breakfast at our hotel. We will have another full-day excursion today, but our destination will be Grasse, "the capital of perfume". Firstly, we will take a guided walking tour of the town, followed by an exciting visit to one of the local perfume laboratories. We will have lunch in Grasse followed by a visit to the Medieval town of St. Paul de Vence for shopping-and-browsing. We will return to our hotel late that afternoon. Dinner and overnight at our hotel. (CB, L, D)

**DAY 6: AIX-EN-PROVENCE:** Breakfast at our hotel. Another wonderful full-day excursion has been planned for us this day when we visit the capital of the Provence region - Aix-en-Provence - which is also the home of the famous French impressionist painter, Paul Cezanne. Our morning will be occupied with a walking tour of the Old Town section of the city, led by a local guide. After our lunch in Aix-en-Provence, we will have an opportunity to visit Cezanne's workshop. Return to our hotel in Cannes for dinner and overnight. (CB, L, D)

**DAY 7: ST. TROPEZ:** Breakfast at our hotel. Today, we will have a wonderful excursion to St. Tropez, the famous haunt for celebrities, artists and couture. Our time here will be at leisure to enjoy a *pastis* (*the national cocktail of France*) in one of the many sidewalk cafés in the old port or browse through the many charming shops and boutiques. A box lunch will be provided. We will return to Cannes in the late afternoon for dinner followed by a visit to the world-famous casino in Monte Carlo. (*Dinner Dress/Jacket and Tie Required*) Dinner is on your own this evening. Overnight. (CB, L)

**DAY 8: CANNES:** Breakfast at our hotel, followed by the remainder of the morning at our leisure to relax, explore, or shop. We will enjoy a free afternoon in Cannes to stroll along the boulevard, soak up some sun at the wonderful beaches, or just enjoy an aperitif at a sidewalk café. We will return to our hotel for a "Farewell Dinner". Overnight. (CB, D)

**DAY 9: NICE~ZURICH~BOSTON:** Breakfast and hotel check-out. Transfer to the Nice Airport to board our return Swiss flight to Boston (*via Zurich*) with full meal and beverage service, as well as stereo headsets, available while in-flight. (CB)
