**DAY 1 – BOSTON-LONDON:** Depart Boston's Logan International Airport aboard our transatlantic flight to London, England with full meal and beverage service, as well as stereo headsets, while in flight.

We will have a half-day orientation tour of the city to get our bearings and see some of the major sights. Later, check in at the Thistle Euston Hotel, with the remainder of the day is at your leisure. Dinner is on our own. Overnight.

**DAY 3 – LONDON:** After Breakfast at our hotel we are hosted to a half day guided panoramic tour of London. Lunch and dinner is on our own. Overnight. (BB)

Emergency evacuation is covered up to \$50,000. Accident or Sickness Medical Expense is covered up to \$25,000. Lost or stolen baggage/personal effects are covered up to \$2500. Baggage delay (24 hours or more) up to \$250 reimbursement, and death or dismemberment benefit \$25,000 max.
