OUR LONDON, ENGLAND & SCOTLAND TOUR ITINERARY:

DAY 1 – BOSTON~LONDON: Depart Boston's Logan International Airport aboard our transatlantic, non-stop flight to London, with full meal and beverage service, as well as stereo headsets, while in flight.

DAY 2 – LONDON: Upon arrival at the airport in London, we will meet our Tour Escort, who will help us transfer. Board our private motorcoach for the ride into London, where we will enjoy a panoramic guided sightseeing tour of many of this historic city's most famous landmarks. Along the way, we will also stop for a sumptuous 3-course lunch with coffee at a nearby restaurant/pub. Later in the afternoon, we will check into the first-class St. Giles Hotel (or similar). Dinner and overnight at our hotel. (L, D)

DAY 3 – LONDON: After breakfast at our hotel, we will take a full day of guided sightseeing in the city of London, including entrance to Saint Paul's Cathedral, the Tower of London, a ride on the London Eye (also known as the Millennium Wheel, the tallest observation wheel in the world), and many other historic sites. We'll enjoy dinner at a local restaurant/pub this evening. Overnight. (B, D)

DAY 4 – BATH~STONEHENGE: After breakfast, we will take a full day of guided sightseeing, beginning in the ancient Roman town of Bath. It was here in the first century AD that the Romans discovered Great Britain's only hot spring and built what has become known as the Roman Baths and Pump Room. In the afternoon, we will visit what may be one of the most recognizable ancient settings in the world – Stonehenge! Return to London for dinner at a local restaurant/pub this evening. Overnight. (B, D)

DAY 5 – WINDSOR CASTLE~HAMPTON COURT: After breakfast, we will head east to the County of Berkshire, where we will tour magnificent Windsor Castle, the official residence of the Queen and the largest inhabited castle in the world. This afternoon, we will tour the former royal residence of Hampton Court Palace, begun by Cardinal Wolsey in 1514 and enlarged by Christopher Wren in the late 1800's. Return to London for dinner at a local restaurant/pub this evening. Overnight. (B, D)

DAY 6 – OXFORD~STRATFORD-ON-AVON: After breakfast, we will enjoy a full day of guided sightseeing, starting in the venerable university and cathedral city of Oxford, including entrance to Christ Church College. Next, we will visit the Tudor-style town of Stratford-on-Avon, home of the famous playwright William Shakespeare, including entrance to his birthplace. Last on today's agenda is a scenic ride through the picturesque Cotswold Hills. Return to London for dinner at a local restaurant/pub this evening. Overnight. (B, D)

DAY 7 – LONDON AREA: After breakfast, we will enjoy a guided sightseeing tour, beginning at historic Westminster Abbey, London's greatest Gothic church, founded by Edward the Confessor in the 11th century. Then we'll visit the Imperial War Museum, an historical repository for all the wars and campaigns Great Britain has been involved in since 1914. Next we will have some leisure time for shopping and browsing at Harrods and in the Knightsbridge area. Dinner, with live music, at a local restaurant/pub this evening! Overnight. (B, D)

DAY 8 – LONDON~EDINBURGH: After breakfast and hotel check-out, we transfer to the train station in London to board the train for our journey north to Scotland. Arriving in Edinburgh, we will be hosted on a panoramic guided sightseeing tour of many of the city's most famous sites. Afternoon check-in at the first-class Edinburgh Capital Hotel (or similar). Dinner and overnight. (B, D)

DAY 9 – EDINBURGH~DRYMEN: After breakfast and hotel check-out, we will continue our guided sightseeing in Edinburgh, including views of Edinburgh Castle, the Royal Mile, Holy Rood Palace, famous Princes Street, and the magnificent Georgian terraces of "New Town." The afternoon is at leisure for sightseeing on our own and shopping. Late afternoon, we depart for Drymen where we will check into the first-class Buchanan Arms Hotel (or similar). Dinner and overnight. (B, D)

DAY 10 – PERTH~ROYAL DEESIDE~BRAEMAR~STIRLING: After breakfast, we will enjoy a drive to the ancient Scottish capital of Perth before taking the road through Royal Deeside to Braemar, the city famous for its Highland Games. We will view Balmoral Castle on the way to

the quaint highland town of Ballatar, a favorite vacation spot of the Royal Family. Time permitting, we'll have a stop for a "quick nip" of whiskey at the Royal Lochnager Distillery before returning to Drymen. Dinner and overnight (B, D)

DAY 11 - GLASGOW~AYRSHIRE: After a full Scottish breakfast, we will enjoy an excursion to Glasgow to view the famous Burrell Collection. Then, we will take a tour through the County of Ayrshire – Robert Burns Country – where we will visit the Robert Burns Heritage Centre and the Robert Burns Cottage, before continuing down the picturesque Ayrshire Coast to Culzean Castle, which is strongly linked to the Kennedy family. Return to our hotel in Glasgow, where we will all gather for a "Farewell Dinner" this evening. Overnight. (B, D)

DAY 12 – GLASGOW~LONDON~BOSTON: After breakfast and hotel check-out, we transfer to the Glasgow Airport to board our return flight to Boston (*via intermediate city*), with full meal and beverage service, as well as stereo headsets, while in flight. (B)
