OUR NORTHERN NATIONAL PARKS ITINERARY:

DAY 1 BOSTON-SEATTLE- Depart Boston on our early morning flight to Seattle (possible intermediate stop). Welcome to Seattle! Enjoy your day to explore this vibrant city before joining your tour manager and fellow travelers for a welcome wine and cheese reception. (Overnight in Seattle)

DAY 2 OVERNIGHT ABOARD AMTRAK- Enjoy breakfast before your sightseeing tour of Seattle. Lunch is on your own before we board Amtrak for our journey to Montana and Glacier National Park. Dinner is included on the train. (Overnight on the train) **B, D**

DAY 3 GLACIER NATIONAL PARK- Enjoy breakfast on the train before we arrive in Glacier National Park. Take some time getting settled in at the Glacier Park Lodge before taking a boat cruise of the scenic Two Medicine Valley. (Overnight in Glacier National Park) **B, D**

DAY 4 GLACIER NATIONAL PARK- This morning, tour Glacier National Park. Travel along the rugged eastern slopes and follow the carved valley of the region along the "Going-to-the-Sun Road". (Overnight in Glacier National Park) **B, D**

DAY 5 GLACIER NATIONAL PARK TO YELLOWSTONE NATIONAL PARK
Board a private motorcoach transfer to Yellowstone National Park this morning. Upon arrival, spend the remainder of the day taking in the natural beauty of the world's first national park. (Overnight in Yellowstone National Park) **B, D**

DAY 6 YELLOWSTONE NATIONAL PARK- Today, tour Yellowstone's upper loop and Lamar Valley. End the tour in Old Faithful Village and check in to your new accommodations. (Overnight in Yellowstone National Park) **B, D**

DAY 7 YELLOWSTONE NATIONAL PARK TO JACKSON HOLE- This morning, tour Yellowstone's lower loop before driving to Grand Teton National Park. Enjoy a tour of this majestic park and the Teton Range. Arrive in Jackson Hole this evening. (Overnight in Jackson Hole) **B**

DAY 8 JACKSON HOLE TO SALT LAKE CITY- Spend the morning at leisure in Jackson Hole. Then take a scenic ride south to Salt Lake City. Upon arrival, explore this pristine city on your own. (Overnight in Salt Lake City) **B**

DAY 9 SALT LAKE CITY- Today, take a guided city tour of the "Crossroad of the West." Visit the historic Temple Square, Pioneer Park, and much more! This evening, enjoy dinner at a popular Salt Lake City restaurant as you say goodbye to the rest of the group. (Overnight in Salt Lake City) **B, D**

DAY 10 SALT LAKE CITY-BOSTON- Your journey ends today with many memories of a great trip! Transfer to the airport in Salt Lake City for your return flight to Boston (possible intermediate stop). **B**
