OUR TOURNAMENT OF ROSES PARADE NEW YEAR'S EXTRAVAGANZA ITINERARY

DEC 29 – BOSTON~LOS ANGELES: Morning departure from Boston's Logan Airport aboard our regularly scheduled flight. Midday arrival in California. Check-in at the *Hyatt Regency Long Beach* (or similar) for a "Welcome Dinner" and overnight. (D)

DEC 30 –DISNEYLAND OR PALM SPRINGS OR HOLLYWOOD TOUR: Full American buffet breakfast at our hotel. Today is another day with options. We can either go to Disneyland for the day, we can visit Palm Springs (includes lunch and the "Palm Springs Follies", or we can tour Hollywood and see the parade floats being decorated. The evening is at leisure, and dinner will be on our own. Overnight at our hotel. (B)

DEC 31 – UNIVERSAL STUDIOS OR RONALD REAGAN LIBRARY OR CATALINA ISLAND: Full American buffet breakfast at our hotel. Today, we have the choice between visiting Universal Studios and take a tour, or to heading to the Ronald Reagan Library (note: the *Ronald Reagan Library tour includes lunch*), or ferrying to Catalina Island for the day. Afterwards, we will attend a New Year's Eve Party with dining, dancing, and casino fun! Overnight at our hotel. (B, D)

JAN 1 – TOURNAMENT OF ROSES PARADE: Early hotel departure for the Tournament of Roses Parade. Breakfast-to-go en route to the parade. Arrive in Pasadena for the 124th Tournament of Roses Parade at our special Grandstand reserved seating (includes seat cushion and an official souvenir program). Champagne brunch at the restaurant after the parade, with the remainder of the day at leisure. Dinner will be on our own. Overnight at our hotel. (B, L)

JAN 2 – SHOWCASE OF FLOATS/BEVERLY HILLS: Full American buffet breakfast at our hotel, followed by a visit to view the parade floats 'up-close' at the post-parade "Showcase of Floats!" We will then enjoy a farewell lunch in Beverly Hills, and have the afternoon at leisure. The evening will be at leisure, and dinner will be on our own. (B, L)

JAN 3 – LOS ANGELES-BOSTON: Following breakfast and hotel check out, we transfer to the airport to board our return flight to Boston. (B)
