### OUR 6-DAY/5-NIGHT TOUR OF SOUTHERN CALIFORNIA ITINERARY:

**DAY 1 – BOSTON-LOS ANGELES-TEMECULA:** Morning airport transfer to Boston’s Logan Airport where we will board our transcontinental flight to Los Angeles. Upon arrival, our group will meet with our driver and guide for a sightseeing tour of Los Angeles, including Hollywood, and a drive to view the “Homes of the Stars”. Late afternoon arrival at the 4-diamond rated *Pechanga Resort & Casino* in Temecula for check-in. Then, some free time to freshen-up prior to our “Welcome Dinner” this evening at the resort. *Each evening, is at leisure for gaming at the Casino, or to take advantage of the many entertainment venues at the resort.* Overnight. (D)

**DAY 2 – SAN DIEGO:** After breakfast, we are off for a full-day in beautiful San Diego including a guided sightseeing city tour. We will stop around noon for lunch (*on our own*), followed by an afternoon at leisure with time to browse-and-shop or just explore on our own. Return to the resort for dinner and an evening at leisure. (BB, D)

**DAY 3 – PALM SPRINGS:** Following breakfast, we will have an enjoyable morning drive to the famous resort of Palm Springs for a guided sightseeing tour. We will also enjoy a scenic and exciting ride on the funicular gondola to the top of nearby 8,500-foot high Mount San Jacinto. The nearly vertical ride is breathtaking and the view from the top is truly spectacular! Return to the resort for dinner and an evening at leisure. Overnight. (BB, D)

**DAY 4 - DISNEYLAND:** This morning, following breakfast at the resort, were off for a full-day at the granddaddy of all theme parks - Disneyland! (*Ticket included.*) The entire day is on our own while at Disneyland. We will depart the park late in the afternoon and return in time for dinner. Evening at leisure. Overnight. (BB, D)

**DAY 5 – PECHANAGA RESORT & CASINO:** Breakfast at the resort. Today is a full-day at leisure to take advantage of the many amenities the *Pechanga Resort & Casino* has to offer. An optional tour is available to the San Diego Zoo. This evening, our group will gather for a special “Farewell Dinner” at the *Piazano Italian Restaurant*. The remainder of the evening is at leisure. Overnight. (BB, D)

**DAY 6 – TEMECULA-LOS ANGELES-BOSTON:** After breakfast and check-out at the resort, we will transfer to the airport in Los Angels for our return flight to Boston. (BB)
