### OUR 10-DAY/8-NIGHT SPAIN/ANDORRA/FRANCE ITINERARY:

**DAY 1 – BOSTON~INTERMEDIATE CITY~BARCELONA:** Depart Boston's Logan International Airport aboard our transatlantic flight to Barcelona (via intermediate city) with full meal and beverage service, as well as stereo headsets, available in flight.

**DAY 2 – BARCELONA:** "Bienvenida a España!" Upon arrival at the Barcelona Airport, we will meet our tour escort, who will help us transfer to Barcelona via motorcoach to check into our hotel. The remainder of the day is at leisure to familiarize ourselves with our surroundings. Dinner and overnight at our hotel. (D)

**DAY 3 – BARCELONA:** After breakfast at our hotel, we will enjoy a guided sightseeing tour of Barcelona. Our tour includes entrance to Sagrada Família, the unique Roman Catholic cathedral, and Park Güell, a garden complex with architectural elements situated on the hill of El Carmel in the Gràcia district. Both were designed by the Catalan architect Antoni Gaudí and built between the years 1882 to 1914. After sightseeing we'll enjoy some time at leisure before dinner at our hotel. Overnight. (B, D)

**DAY 4 – BARCELONA~ANDORRA LA VELLA~TOULOUSE:** After breakfast and hotel check-out, we'll board our motorcoach and leave Spain, passing into Andorra. We will visit Andorra La Vella, where we enjoy a half-day, guided sightseeing tour of the small country's capital. While in the area, we will have an opportunity for a view of Iglesia De San Joan de Caselles in Canillo, a fine example of Romanesque architecture built in the 12th century. Lunch is on our own en route to Toulouse, where we will check into our hotel. Dinner and overnight. (B, D)

**DAY 5 – TOULOUSE:** After breakfast, we are off on a half-day guided city tour of Toulouse, including visits to the Basilique St. Sernin and Salle Des Illustres. The largest Romanesque church in Europe, the Basilica of Saint Sernin is notable for its imposing architecture and important medieval sculptures and frescoes. In the heart of the capital, the impressive Salle Des Illustres exhibits the work of Toulouse artist from the end of the 19th century to the beginning of the 20th. Return to the hotel for dinner and overnight. (B, D)

**DAY 6 – LOURDES:** After breakfast, we'll travel to Lourdes, France. Upon arriving in Lourdes, we'll enjoy a half-day guided tour sightseeing tour. We will visit the Grotto De L'Apparition (most popularly known as the Domain). The sanctuary is a destination for pilgrimage; pilgrims are reputed to be miraculously healed by Lourdes water. Included is entrance to The Basilica of St. Pius X, known as the Underground Basilica, the largest and most controversial of the Domains churches. The last part of our sightseeing in Lourdes includes a visit to Cachot, a former jail and where the Souboribus family lived. It is said that St. Bernadette went through a fairly extensive period of apparitions, and it was during the time she lived in this small house. Return to our hotel for dinner and overnight. (B, D)

**DAY 7 – TOULOUSE~BORDEAUX~PARIS:** After breakfast and hotel check-out, we'll head for Bordeaux, where we'll take a half-day sightseeing tour of the city. The French are passionate about wine! While we are in wine country, where better to share in their enthusiasm than at our Station Wine Tasting at La CUV? Later this afternoon we travel first-class by TGV (high speed) train from Bordeaux to Paris, where we'll check into our hotel for dinner and overnight. (B, D)

**DAY 8 – PARIS:** After breakfast, we'll enjoy a full-day, guided sightseeing tour of the City of Light, where we will have an opportunity to view the magnificent Arc de Triomphe and the Avenue des Champs-Élysées. Entrance to the Eiffel Tower, level two, is also included. After lunch (on our

own), we'll visit the miraculous Medal Chapel to see the body of Saint Catherine Laboure and the heart of St. Vincent De Paul. Dinner and overnight. (B, D)

**DAY 9 – PARIS:** After breakfast, the rest of our day is at leisure to enjoy Paris. As the Louvre will have been closed on Day 8, we may want to make our way to that famous museum for a portion of the day, or we may choose to do other individual sightseeing. Shopping or relaxing and people-watching at a sidewalk café also great possibilities in this city. Dinner and overnight at our hotel. (B, D)

**DAY 10 – PARIS~POSSIBLE INTERMEDIATE CITY~BOSTON:** After breakfast and hotel check-out, we will transfer to the airport where we will board our return flight to Boston (*via possible intermediate city*) with full meal and beverage service, as well as stereo headsets, available while in flight.
