## OUR CHERRY BLOSSOM FESTIVAL TOUR ITINERARY:

**DAY 1: Boston~Washington, DC.** Transfer to Logan Airport for our flight to Dulles International Airport. Upon arrival, we'll meet our full-time Tour Escort. First we'll visit the Smithsonian Institution's Stephen F. Udvar-Hazy Center, which displays over 335 aircraft, including the Space Shuttle Enterprise and the Enola Gay. Then we'll check into *Marriott Tysons Corner* (or similar) where we'll enjoy a welcome dinner this evening. Overnight. (D)

**DAY 2: Old Town Alexandria~Arlington Cemetery~Air Force and September 11 Memorials at Night.** After breakfast, we'll visit Mount Vernon. After lunch (*on our own*), we'll have some free time in Old Town Alexandria. We can visit Christ Church where George Washington and Robert E. Lee had pews. Then we'll take a driving tour of Old Town. Later we'll board the tram for a visit to Arlington National Cemetery and see the changing of the guard at the Tomb of the Unknown Soldiers. After dinner, we'll visit the Air Force Memorial and the September 11, 2001 Memorial at the Pentagon. Overnight. (B, D)

**DAY 3: National Cherry Blossom Parade~Capitol Hill~National Portrait Gallery~Illuminated Monument Night Tour.** After breakfast, we'll take our reserved premium-view seats at the National Cherry Blossom Parade. After the parade, we'll transfer to Capitol Hill and see the U.S. Capitol Building, the Library of Congress, and have a photo opportunity of the Supreme Court Building. We'll continue with a visit to the National Portrait Gallery. Tonight we'll enjoy dinner at the famed Carmine's Italian Restaurant. After dinner, we'll take an Illuminated Monument Tour, with stops at the Kennedy Center and the Iwo Jima Statue. We'll also drive by other memorials and monuments illuminated at night. Overnight. (B, D)

**DAY 4: Washington, DC Tour~Odyssey Cruise~Smithsonian Museums.** After breakfast, we'll visit the National World War II Memorial, the Vietnam Veterans Memorial, the Lincoln Memorial, and the Korean War Veterans Memorial. Next we'll enjoy a Potomac River lunch cruise onboard the Odyssey III. After lunch, we'll visit the museums of the Smithsonian Institution on the National Mall. We'll enjoy a special farewell dinner. Overnight. (B, L, D)

**DAY 5: Washington, DC Memorials~Newseum~Boston.** After breakfast and hotel check-out, we will visit the Newseum, the only interactive museum dedicated to news. After lunch (*on our own*), we'll depart for the new Martin Luther King, Jr. National Memorial. We'll also visit the Franklin D. Roosevelt Memorial, the Jefferson Memorial, and stop for a photo opportunity of the cherry trees (*pending bloom time*). Then we'll head to Dulles International Airport for our return flight. (B)
